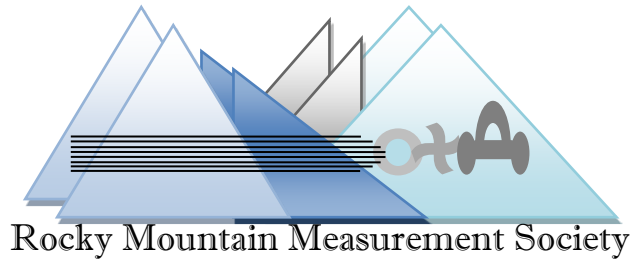

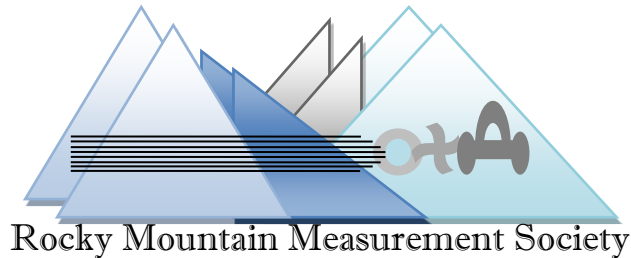

## Eligibility Requirements

- Scholarship winners will be chosen on a competitive basis, based on qualities or leadership, extracurricular accomplishments and the student's self-description of interests and goals.
- Scholarship winners will be chosen without regard to family financial circumstances or social status.
- Priority will be given to sons and daughters of RMMS members in good standing.
- Candidates must be:
  - Accepted to or attending an accredited institution of higher learning
  - GPA of 2.75 or higher
  - Citizen of the United States of America
  - Foreign students with a student visa
  - Willing to provide, upon committee's request, all biographical and academic information requested on the application, including certified transcripts and acceptance letter to an accredited institution of higher learning.
  - In good academic and disciplinary standing as determined by the Scholarship Committee.

## Implementation Guidelines

- The purpose of the scholarship is to identify, support and encourage continued education for talented local measurement industry members and family. We provide an opportunity for corporations, foundations and other organizations that wish to contribute towards a college scholarship fund for individuals connected to the Rocky Mountain Measurement Society.
- The Scholarship Committee is composed of the Board of Directors of the RMMS of the effective fiscal year.
- The Scholarship Committee will make the recipient selections. If a candidate is a son or daughter of a member of the Scholarship Committee, then that Scholarship Committee member will relinquish his or her voting rights for that candidate.
- Scholarships will be awarded during each fiscal year of the RMMS, typically on or about the traditional start of the school year (i.e. September).
- The scholarship program may be suspended or terminated at any time by the decision of the Board of Directors.



## Rocky Mountain Measurement Society Scholarship Details

1. Purpose – The purpose of the scholarship is to identify and honor exceptional students and to provide a system of services for corporations, foundations, and other organizations that wish to sponsor a college scholarship for outstanding participants who interest them in the Rocky Mountain Measurement Society.
2. Type – The scholarship will be awarded on an annual basis, typically on or about the traditional start of the school year.
3. Amount awarded – The amount awarded will be dependent on available funds, number of selected recipients, and the discretion of the scholarship committee. The scholarships will be funded from earnings from the following sources:
  - a. Society Membership Dues
  - b. Any profits from Society Meetings
  - c. Profits from Society Fundraiser(s)
4. Scholarship Criteria
  - a. Accepted to or attending an accredited institution of higher learning.
  - b. Incoming Students:
    - i. Cumulative High School GPA of 2.75 or higher
  - c. Enrolled Students Either:
    - i. Cumulative GPA of 2.75 or higher
    - ii. Previous Semester/Trimester GPA of 2.75 or higher
  - d. Citizen of the United States of America or attending a domestic institution while on a student visa.
  - e. Willing to provide, upon committee's request, all biographical and academic information requested on the application, including certified transcripts and acceptance letter to an accredited institute of higher learning.
  - f. In good academic and disciplinary standing as determined by the scholarship committee.
5. Name – The Rocky Mountain Measurement Society Scholarship
6. Scholarship Administrator – The administrator of the scholarship is composed of the Board of Directors of the Rocky Mountain Measurement Society and Advisors.
  - a. If a candidate is a relative of a member of the Scholarship Committee, then that committee member shall relinquish his or her voting rights for that candidate.
